Procurement Advantages

- ✓ **Direct Award:** ANC 8(a) entities may receive direct award Federal contracts of any size. Unlike individually-owned 8(a) concerns, we are not subject to the \$4.5M cap on direct award contracts for non-manufacturing services per FAR 19.805-1(a)(2).
 - **DoD:** Per DFARS 219.808-1(a), ANCs may receive DoD sole source contracts up to \$100M without a J&A. For acquisitions over \$100M, a more streamlined J&A is required per FAR 6.303-2(d) and the approval authority is the head of the procuring activity per DFARS 206.304(S-71).
 - Federal: Per FAR 19.808-1(a), ANCs may receive sole source contracts up to \$25M without a J&A. For acquisitions over \$25M, a more streamlined J&A is required per FAR 6.303-2(d) and the approval authority is head of procurement activity per FAR 6.304(a)(3).
- ✓ **Non-Protestable:** Sole source awards made to ANC 8(a) firms cannot be protested per 13 CFR 124.517.
- ✓ Past Performance: GAO permits ANCs to claim all the experience and work history of its affiliated corporations when the proposal makes clear that the resources associated with the affiliated company/companies will have meaningful involvement in the execution of the present contract. - ✓ **5% Incentive Program:** DoD Contractors who offer subcontracts to ANC 8(a) firms receive 5% of the total value of the subcontract as an incentive per Section 504 of the Indian Financing Act of 1974 (25 USC 1544).
